- 1. **Assumption of Risk**: All participants engage in boat activities at their own risk. BC Lifestyle is not liable for any personal injury, personal property damage, or loss of personal belongings that may occur during the activity.
- 2. **Safety Protocols**: All participants must comply with safety protocols, including but not limited to always wearing a life jacket and remaining seated while the boat is in motion.
- 3. **Prohibited Actions**: Exiting the boat for swimming or any other purpose while the boat is in motion is strictly prohibited.
- 4. **Property Damage**: Participants are responsible for the full replacement cost of any damage caused to the boat property.
- 5. **Substance Policy**: The consumption of alcohol, smoking, or use of drugs is strictly prohibited while the boat is in motion.
- 6. **Participant Eligibility**: Individuals who are heavily pregnant (seven months or more), minors, or persons with disabilities must be accompanied by a guardian to participate.
- 7. **Prohibited Items**: The following items are strictly prohibited on board and will not be permitted:
  - · Weapons, including knives, guns, bottles, and sharp objects.
  - Alcoholic beverages, drugs, cigarettes, or any smoking materials.

## Quad-Biking Disclaimer and Liability Agreement

By participating in any activities offered by BC Lifestyle quad-biking, you acknowledge and agree to the following terms and conditions:

- Assumption of Risk: All participants engage in quadbike activities at their own risk. BC Lifestyle is not liable for any personal injury, personal property damage, or loss of personal belongings that may occur during the activity.
- 2. **Safety Protocols**: All participants must comply with safety protocols, including but not limited to always wearing a helmet, remaining seated while the bike is in motion, complying with the speed limit and following the route as guided by the tour guide.
- 3. Prohibited Actions: Standing on and jumping off the bike while the bike is in motion is strictly prohibited.
- 4. **Property Damage**: Participants are responsible for the full replacement cost of any damage caused to the quadbike.
- 5. **Substance Policy**: The consumption of alcohol, smoking, or use of drugs is strictly prohibited while the bike is in motion.
- 6. **Participant Eligibility**: Individuals who are heavily pregnant (seven months or more), minors, or persons with disabilities that prohibit the effective quadbike operation, and the elderly (70 years +) are not allowed participate.
- 7. **Prohibited Items**: The following items are strictly prohibited on board and will not be permitted:
  - Weapons, including knives, guns, bottles, and sharp objects.
  - Alcoholic beverages, drugs, cigarettes, or any smoking materials.
